IT ALSO MONITORS THE IMPLEMENTATION OF THE **INTERNATIONAL CONFERENCE ON POPULATION & DEVELOPMENT PROGRAMME OF ACTION (ICPD PoA)**, WHICH PLACES PEOPLE'S NEEDS & RIGHTS AT THE CENTRE OF DEVELOPMENT PLANS.

- 1 WEEK LONG
- UNITED NATIONS, NEW YORK, US



IT COMPRISES OF 3 PARTS:

- FORMAL** - OPEN TO EVERYONE
- INFORMAL** - MEMBER STATES ONLY
- SIDE EVENTS** - CREATIVE, YOUTH FRIENDLY

THE CPD REQUIRES REGISTRATION FOR ATTENDANCE.
